**Tax Levy Renewals** –adopted the Resolutions to Proceed which allow the question of a five year levy for 6 mills and a five year levy for 5.9 mills to be placed on the November 3, 2015 ballot.

The **renewal of the 6 mill levy** will continue to provide \$3,274,834 each year for the District's current expenses. This levy was first passed in 1991. The current effective residential rate is 3.990588.

The **renewal of the 5.9 mill levy** will continue to provide \$3,905,538 each year for the District's current expenses. This levy was first passed in 1996. The current effective residential rate is 4.686617.

**Salary Correction** –approved a payment to **Timothy Saxton**, Director of Operations, for 20 days worked in the month of July 2013. Mr. Saxton did not receive pay for these days due to an error in calculations in the conversion from his previous contract as high school principal.

**Athletic Manual** –approved the high school athletic manual.

**Bus Sale** –approved the sale of spare bus #45 to the Boardman Band & Orchestra Parents (BBOP) for \$1.00. The band parents plan to use the spare bus as a box truck so that they will no longer need to rent a box truck for away athletic contests or performances. Spare bus #45 is a 1998 Thomas Transit and is worth \$1,500.00 to \$2,000.00 for scrap metal.

**Parental Contracts** - granted the Superintendent permission to approve parental contracts as needed for the 2015-2016 school year. Parental contracts are issued in accordance with ORC 3327.012 where the transportation of students by school bus conveyance is declared impractical.

**School Bus Routes** - Per ORC 3301-83-13A, approved all school bus routes and student pick-up and drop-off locations for the 2015-2016 school year as prepared by the Transportation Office.
