**2015-2016 Tuition Rate** –approved the tuition rate as established by the State Department of Education for the 2015-2016 school year. The tuition rate established through ORC 3317.08 is \$41.26 per day for 178 attendance days.

**Funds Transfer** - approved the transfer of funds from the 001 General Fund to the 003 Permanent Improvement Fund for the purpose of future Capital Project(s) needs.
